VACANCY CIRCULAR

Subject: Filling up the posts of Deputy Secretary and Under Secretary in the National Commission for Minority Educational Institutions (NCMEI), New Delhi, on deputation basis – Calling for applications – regarding.

The undersigned is directed to inform that it has been decided to fill up the posts of Deputy Secretary and Under Secretary in the NCMEI, New Delhi, a statutory body under the Ministry of Education, Government of India on deputation basis.

2. **The number of vacancies, classification of posts, method of recruitment, age, eligibility criteria and period of deputation, etc. are attached as Annexure - I.**

3. It is requested that the applications (three copies) of willing and eligible candidates who can be spared immediately on selection, may kindly be forwarded to Shri B. K. Mahanta, Director, Ministry of Education, Government of India, Room No. 6 A, 4th Floor, Jeevandeep Building, Parliament Street, New Delhi -110001, in hard copy within 60 (Sixty days from the date of issue of advertisement in the Employment News/Rozgar Samachar in the prescribed format (**Annexure II**) along with all the requisite documents i.e. attested copies of latest 05 years APARs (each page attested by an officer not below the rank of Under Secretary), DE/Vigilance Clearance, Statement showing major/minor penalty, if any, imposed on the officers during the last 10 years, Integrity Certificate and Cadre Clearance etc. Further, soft copy (PDF format) of application along with relevant documents may also be emailed within prescribed time limit at bk.mahanta@nic.in. The extension of last date of receipt of application, if any, will be notified /uploaded in the website of Ministry.

4. While forwarding the applications, it may also be verified and certified that the particulars furnished by the officers are correct and that no vigilance case is either pending or contemplated against them and no major/ minor penalty has been imposed on the officers during the last 10 years. Applications received after due date or without the above-mentioned requisite documents or otherwise found incomplete will not be considered and summarily rejected. Advance copy of the application will not be entertained. The candidate, in the event of his/her selection, will not be allowed to withdraw his/her candidature subsequently on any ground.

5. The deputation will be governed in accordance with the provisions contained in DOPT OM No. 6/08/2009- Establishment (Pay-II) dated 17.6.2010, and OM No. 2/11/2017-Establishment (Pay-II) dated 24.11.2017 and 15.03.2021 as amended from time to time.

Officers holding analogous posts in any cadre or department may also be considered for appointment on

deputation, subject to the condition that they possess experience of working with quasi-judicial bodies.

The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in other organization/department of the Central Government shall ordinarily not exceed five years.

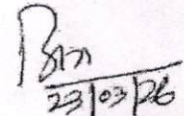

ORDER

In exercise of the powers conferred under Rule 5 of the National Commission for Minority Educational Institutions (NCMEI) Recruitment Rules, 2016, and after careful consideration of the proposal of the National Commission for Minority Educational Institutions, the Central Government, being of the opinion that it is necessary and expedient to do so in the public interest and for the smooth functioning of the Commission, hereby relaxes the eligibility conditions relating to qualifying service/experience prescribed under the said Rules for filling up the posts of Deputy Secretary and Under Secretary in NCMEI.

2. The relaxation shall be applicable as under:
 - (i) The qualifying service/experience prescribed in the NCMEI Recruitment Rules, 2016 for the posts of Deputy Secretary and Under Secretary shall stand relaxed by two years from the existing requirements.
 - (ii) Officers holding analogous posts in any cadre or department may also be considered for appointment on deputation, subject to the condition that they possess experience of working with quasi-judicial bodies.
3. The above relaxation is granted as a one-time measure, and shall be applicable only for filling up the present vacancies of Deputy Secretary and Under Secretary in the National Commission for Minority Educational Institutions.
4. This relaxation shall not be treated as a precedent for future recruitments.
