**Subject: - Declaration of marks of online examination (Tier-I) held on 30/06/2025 for the post of Assistant Director (Horticulture), Post Code – 28/24 in Municipal Corporation of Delhi & shortlisting of candidates for Tier-II (Part – I subject/Qualification related paper, Part-II Descriptive Test) - regarding.**

1. The DSSSB vide advertisement No. 05/2024 dated 05/03/2024 had advertised **13 Vacancies (UR-08, EWS-01, OBC-03, SC-01, ST-Nil including PwBD- 01 (a) category, ExSM-Nil, SP-Nil)** for the post of **Assistant Director (Horticulture) in Municipal Corporation of Delhi, under post code – 28/24**. The online examination was held on 30/06/2025.

2. The marks obtained by **118 candidates** who duly appeared in written examination conducted (online mode) on 30/06/2025 for the Post of Assistant Director (Horticulture) in Municipal Corporation of Delhi have been uploaded on the OARS module of the Board's website. Candidates can view their marks by logging into their account in OARS module on [www.dsssonline.nic.in](http://www.dsssonline.nic.in).

3. As per Advertisement No. 05/24, the examination scheme for post code – 28/24 is II-Tier Examination. Tier-I (MCQ) examination conducted by the DSSSB on 30/06/2025.

4. Accordingly, based on the performance in the written examination, **46 Candidates (UR-39, EWS- No suitable/qualified candidate found in the merit, OBC-03, SC-04, ST-Nil, PwBD- No suitable/qualified candidate found in the merit)** in the merit have been provisionally shortlisted for appearing in Tier-II Descriptive Test (English Language) subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be informed separately for Tier-II written examination.

5. The cutoff marks of shortlisted candidates for appearing in Tier-II examination is as under:-

**Note:-** For applicants of all technical post, the mandatory minimum qualifying marks in Tier-I Examination will be applicable only in r/o Section-B which is domain subject specific. There will not be any minimum qualifying marks in Section-A. However, combined aggregate marks of both Section-A & Section-B will be reckoned for preparing the final merit list.

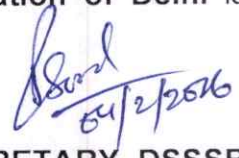

Since documents have not been called from the candidates along-with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of name in the list of candidates qualifying for appearing in Tier-II examination does not entitled them any right over the post.

**7. The shortlisted candidates for the above mentioned post code will be informed separately for appearing in the Tier-II (Part –I subject/Qualification related paper, Part-II Descriptive Test).**
