**Sub: Release of Tier-I marks and shortlisting of candidates for Tier-II Exam
for the Post of Inspecting Officer under Post Code 45/25 in Labour
Department.**

1. The DSSSB vide its vacancy notice/Advertisement No. 02/25 dated 31/07/2025 with closing date 16/09/2025 had advertised **Total – 16 [UR-07, OBC-04, SC-02, ST-01, EWS-02 including PwBD Cat (a)-01 & ExSM-01]** for the post of **Inspecting Officer under Post Code 45/25 in Labour Department.**
2. The Tier-I CBT for recruitment in respect of this post was conducted on 24/02/2026.
3. The Prorated marks obtained by 935 candidates who appeared in written examination have been uploaded on Board's website. Candidates can view their marks by logging in to their account in OARS module on www.dssbonline.nic.in.
4. Based on the performance in CBT Tier-I(MCQ) for 200 marks, the candidates who have secured equal or more marks in their respective category as per the details given below in the table have been provisionally shortlisted for Tier-II subject to correctness of the information furnished by the candidates in their online application forms:

5. As per the examination scheme, the mandatory minimum qualifying marks in Tier-I Examinations will be applicable only in r/o Section-B (100 marks) which is domain subject specific. There will not be any minimum qualifying marks in Section-A (100 marks). However, combined aggregate marks out of 200 marks will be reckoned for preparing the final merit list.
6. The shortlisted candidates shall be called for Tier-II Exam separately.
7. Only those candidates have been considered in OBC Category who has declared that they are OBC (Delhi) in their online application form.
8. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Tier-II does not entitled them any right over the post.
9. The above shortlisted candidates for Tier-II for the post code mentioned above will be subject to outcome of pending court cases, if any.
10. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
11. This issues with the prior approval of Chairperson, DSSSB.

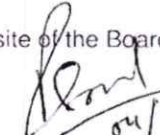
