NOTE :-

1. The result is subject to the fulfilment of eligibility criteria laid down in the Advertisement no.114/2024-25.

2. The main examination of Advt No.:114, 135, 136/2024-25 of Paper-1: Gujarati Language and Paper-2: English Language of all candidates was conducted by the Commission on dated 08-01-2026 and 09-01-2026. An important notice was published on the website of the Commission on 24-12-2025, according to which a link for Self-Declaration has been provided for common candidates who are registered in more than one advertisement. With reference to the advertisement no. 114, 135, 136/2024-25 and looking to the details submitted by the candidate, the marks of the relevant common paper are to be taken into consideration for the common papers of all the relevant advertisements. Accordingly, the marks of the relevant common papers have been considered in the concerned advertisements of the common candidates.
3. (1) As per the Final Answer key of Paper-1:Gujarati Subject, evaluation has been carried out by treating each question with 1.000 mark for the right answer and (-) 0.300 mark for the wrong/multiple encoded/blank answer for objective type multiple choice question.

(2) As per the Final Answer key of Paper-2: English Subject, evaluation has been carried out by treating each question with 1.000 mark for the right answer and (-) 0.300 mark for the wrong/multiple encoded/blank answer for objective type multiple choice question. One (1) objective question of Grammar section is cancelled, therefore it is decided to distribute equally the 1 mark of this cancelled question among the remaining 149 Marks on pro-rata basis and evaluation has been carried out by treating 1.007 marks for each remaining mark (i.e.149)
4. The Provisions of the Commission's Office Orders Dated 17-09-2025, 20-09-2025 and 25-11-2025 have been considered to select the required number of Ex- Servicemen candidates.
5. In order to select the required no. of candidates from Persons with Disability candidates, the provisions of the GAD Resolution NO-CRR-

102017-122639-G-2, Dated 20-11-2024 and GPSC Office Order Dated 04-07-2025 and 20-09-2025 have been considered.

6. The Candidate Bearing Roll No. 101001701 has been conditionally considered Eligible Subject to Medical Examination regarding his disability.
