- h) Independent External Monitors deputed by CVC for AAI for the cases where they were/are IEM.

The applicant should be below 70 years of age as on 09.10.2026

[B] TERMS AND CONDITIONS FOR EMPANELMENT:

1. Term of the panel will be for a period of 03 (Three) years from the date of empanelment which may be extended after 03 years with the approval of the Chairman, AAI. However, AAI reserves its rights to scrap the panel before the expiry of 03 yrs. AAI also reserves the right to expand the panel on need basis anytime during currency of the panel.
2. Empanelment, remuneration and other terms & conditions shall be governed by the provisions of the Arbitration and Conciliation Act, 1996, more specifically, Section 12 read along with Schedule V and VI. The fees of the Arbitrator shall be in accordance with the

provisions of Schedule IV of the Arbitration and Conciliation Act, 1996, as amended from time to time.

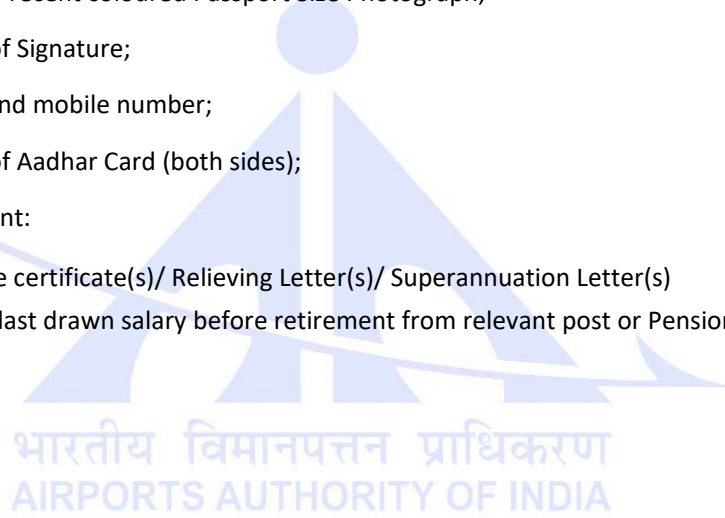
