Vacancy Circular

Subject: Filling up one post of Office Superintendent (General Central Service, Group - 'B' Non - Gazetted, Non - Ministerial) in Central Fertilizer Quality Control & Training Institute, Faridabad (A subordinate office under the administrative control of Department of Agriculture & Farmers Welfare) in the Level-6 of Pay Matrix (7th CPC- Rs. 35,400-1,12,400/-) (pre-revised pay scale of Rs. 9300-34800/- with a Grade Pay of Rs. 4200/- PB-2) on deputation (including short term contract) basis-reg.

It is proposed to fill up one post of Office Superintendent (General Central Service, Group - 'B' Non - Gazetted, Non-Ministerial) in Central Fertilizer Quality Control & Training Institute, Faridabad (A subordinate office under the administrative control of Department of Agriculture & Farmers Welfare) in the Level-6 of Pay Matrix (7th CPC- Rs. 35,400-1,12,400/-) (pre-revised pay scale of Rs. 9300-34800/- with a Grade Pay of Rs. 4200/-, PB-2) on deputation (including short term contract) basis.

2. Eligibility Conditions: - Deputation (including short term contract).

Officers under the Central Government or State Government or Union Territories Administration or Autonomous or Statutory Bodies or Research Institutions or Universities or Public Sector Undertakings:

- i. holding analogous posts or with 10 years' regular service in the Level-4 of Pay Matrix (7th CPC- Rs. 25,500-81,100/-) (pre-revised pay scale of Rs. 5,200-20,200/- with a Grade Pay of Rs. 2400/-, PB-1) and after appointment thereto in the parent cadre or department and having minimum four years' experience in administration and accounts.

The Departmental Officers in feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation (including short term contract). Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

3. Duties and responsibilities attached to the post:

Accounts and Store related work, preparation of BE/RE and submission of reports, all Administrative/ Establishment/ Accounts related work and other work assigned from time to time by

HOO/HOD.

4. Regulation of Pay and other terms of deputation:-

The pay of the officer selected for appointment on deputation basis will be regulated in terms of DOPT's OM No. 6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time.

5. Age- limit:-

The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 (fifty six) years, as on the closing date of receipt of applications.

6. Period of deputation: -

Period of deputation (including short term contract) including the period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of Central Government shall ordinarily not to exceed three years.

For the purpose of appointment on deputation (including short term contract) or absorption basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 or the date from which the revised pay structure based on the 6th CPC recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay or pay scale and where this benefit will extend only for the posts for which that grade pay or pay scale is the normal replacement grade without any up gradation.

7. Place of posting:-

Central Fertilizer Quality Control & Training Institute, Faridabad or anywhere in the existing RFCLs located at Chennai, Navi Mumbai & Kalyani (West Bengal).

8.
