Applications in the prescribed format is invited for preparation of a panel of candidates for the posts of Non P.G. Junior Residents (Dental) for fixed tenure of **one year** only, in the **pay level-10 (Rs. 56,100 – 1,77,500 + NPA and other allowances as admissible)**. There are 22 posts of Junior Residents (Dental) in MAIDS as under:-

1. The Candidates from this panel may also be offered JR-ship in other Delhi Govt. Hospitals, if so required.
2. The candidates kept on panel will be offered appointment against the vacant posts as and when the post of a particular category falls vacant. The Panel shall be valid for a period of 12 months from the date of declaration of final result, or when the next recruitment is carried out, whichever is earlier.

3. The educational qualification, age etc. as stipulated in advertisement shall be determined as on the closing date of submission i.e. on 21/09/2026.
4. Candidates who wish to be considered against reserved vacancies and/or to seek age relaxation, must be in possession of relevant certificate (EWS/SC/ST/OBC (Non-Creamy Layer)/PwD etc.) issued by the Competent Authority on or before the closing date of application, otherwise their claim for reservation in the category will not be considered.
5. OBC certificates issued from Govt. of NCT of Delhi as OBC (Delhi) shall only be accepted.
6. OBC candidates who wish to be considered against the OBC vacancies must have in possession of valid Non-Creamy Layer Certificate for the current financial year.
7. EWS candidates who wish to be considered against the EWS vacancies must have in possession of valid Certificate for the current financial year.
8. The services of Junior Resident shall be governed by residency schemes of Govt. of India.
9. The candidates may be advised to ensure their eligibility criteria before applying for the post. The candidature of ineligible candidates will be rejected outright.
10. Appointment shall be subject to medical fitness & verification of certificates.
11. **AGE LIMIT :** 30 years as on last date of submission of application. Relaxation in age it allowed as per rules.
12. **ELIGIBILITY :**
 - i) Candidates must have completed compulsory rotatory internship on or after 20/09/2024.
 - ii) Applicants having post graduate qualification **are not eligible.**
 - iii) The period for which a candidate has already worked in any Govt. Hospital as Junior Resident (Dental) will be deducted from the maximum period of one year of Junior Residency. Those who have already worked for a period of one year in any Govt. hospitals are not eligible.
 - iv) **All the candidates who have applied with prescribed fee for the post of Junior Resident (Dental) – 2026 will be allowed to appear in the screening test subject to the conditions that the eligibility criteria shall be checked only in respect of the eligible candidates who qualify the written test. In case the candidate fails to fulfill the criteria after qualifying the screening test he/she shall not be eligible for appearing in interview and no correspondence or representation shall be entertained under any circumstances.**
13. **FEE PAYABLE:** Rs. 1000/- for GEN/OBC/EWS candidates, and Rs. 500/- for SC/ST candidates. The fee should be paid in the form of Demand Draft in favour of "Director-Principal, MAIDS", *Payable at New Delhi*. Fee is not refundable in any case. PwD candidates shall be exempted from examination/application fee.
14. **MODE OF SELECTION:** The selection will be made through a Screening Test followed by an interview of the shortlisted candidates. Based on merit, candidates up to three times the number of vacancies in each category will be called for the interview, subject to their fulfilling the eligibility criteria prescribed above.

15. **QUALIFYING MARKS** : 50% marks in UR & EWS category, 45% marks for OBC category and 40% marks for SC/ST/EWS/PwD category. **Qualifying written test does not confer selection.** Candidates called for interview will be formally evaluated on the basis of their performance both in screening test and interview.
16. **HOW TO APPLY** : Complete application in the prescribed format along-with the documents and fee must reach on or before **21/09/2026 up-to 2:00 PM** directly or by post, addressed to **"The Director-Principal, Room No. 501, Fifth Floor, Phase – II Building, Maulana Azad Institute of Dental Sciences, Bahadur Shah Zafar Marg, New Delhi-110002.** The application form is available on the website www.maids.delhi.gov.in. The applicants must fill in the prescribed form only available on the website.
17. **DOCUMENTS TO BE ATTACHED:** Self-attested copies of certificates in support of Age, Caste, **(Non-Creamy Layer Certificate in case of OBC (Delhi) candidates)** Experience, Valid Registration with State Dental Council, Internship Completion Certificate, Attempt Certificate, Marks Statements of BDS pass, BDS Degree/Provisional Certificate, two passport size photographs, Demand Draft details as mentioned above. Certificates for awards, medals, certificates of honors in original & copies of publications, if any to be brought by the candidates at the time of interview.
18. **NEGATIVE MARKING:** In the screening/written test each correct answer earns **4 marks**, while each incorrect answer results in a **(-) 1-Mark** deduction. Unanswered questions receive **zero (0)** marks, and there is no negative marking for questions not attempted.
19. **THE WEIGHTAGE OF WRITTEN EXAM & INTERVIEW:** 40% weightage will be given to the screening test and remaining 60% for weightage spread across pre-defined parameter including interview.
20. Other service conditions will be applicable as per service conditions prescribed from time-to-time by the Govt. of NCT of Delhi.
21. The Institute will not be responsible for any postal delay or delay on the part of any delivery agency, if the application received after closing date of submission of application. **Application received after closing date i.e. 21/09/2026 (up-to 2:00 PM) will not be entertained.**
22. **JURISDICTION OF DISPUTE-** In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi.

NOTE: No TA/DA will be paid for written test and interview.
