ENGAGEMENT OF PART TIME DENTAL SURGEON ON CONTRACT BASIS

Railway Hospital, Rail Wheel Factory, Yelahanka, Bangalore requires the services of a Part-Time Dental Surgeon on Contract basis, initially for a period of one year, who fulfill the following conditions:-

1. Education Qualification: Should possess a Bachelor's Degree in Dental Surgery with atleast 3 years of working experience or must be a Post Graduate.
 - 1.1 The candidate must produce: -
 - a) Bachelor's Degree certificates in support of having passed BDS/MDS for each academic year, along with completed marks sheet for each academic year.
 - b) Certificate in proof of having completed compulsory rotary internship.
 - c) The valid registration certificate issued by Dental Council for having registered name in the respective Dental Council/s. The certificate should have current validity.
 - d) Experience certificate for having practiced dentistry for atleast 3 years.
2. Age limit: The volunteering candidates must be less than 53 years of age, as on 01.08.2026.
3. The Part-Time Dental Surgeon should work in OPD for 4 hrs daily/6 days a week in Railway Hospital of Rail Wheel Factory, Yelahanka, Bengaluru.
4. The rates of consolidated monthly honorarium will be paid as mentioned below:-

Willing candidates may send their applications alongwith biodata and the testimonials duly self attested in support of their qualification, experience, etc., to the Principal Chief Personnel Officer, Rail Wheel Factory, Yelahanka, Bengaluru to reach on or before 29.08.2026. Based on the details furnished in the application, the eligible candidates will be shortlisted for an interview. TERMS & CONDITIONS FOR ENGAGEMENT OF PART-TIME DENTAL SURGEON ON CONTRACTUAL BASIS

1. The contract shall be entered into for a period of one year or less from the date of entering into the contract. Period of contract is not extendable on any grounds. However, the Railway administration shall reserve the right to enter into a fresh contract, for one year or less, with the practitioner or for further contracts. The candidate should not have completed more than 53 years of age as on 01.8.2026. The maximum age limit shall be 65 years or 12 terms whichever is earlier and each term of engagement shall not exceed more than 1 year.
2. Candidate engaged as Part-Time Dental Surgeon will be paid monthly remuneration at the rate of Rs. 36,900/- for four hours daily, six days a week.
3. No remuneration is admissible for absence from duty. The rate of deduction for absence per day is Rs. 1230/-.
4. The Part-Time Dental Surgeon who enters into contract with Railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract.
5. He/She will undertake to work as Part-Time Dental Surgeon for a period of one year. This contract is liable to be terminated at any time on 15 days' notice on either side. RWF administration reserves the right not to assign any reason for such termination. Contract shall also be terminated forthwith if the Part-Time Dental Surgeon is found to be mentally or physically incapacitated.
6. At the time of entering into contract, the Part-Time Dental Surgeon shall produce certificates of his/her character and antecedents from two gazette officers of Central/State Government.
7. Candidate has to produce original certificates for proof of his/her date of birth and educational qualifications. The Part-Time Dental Surgeon must have three years working experience or be a post-graduate.
8. The Part-Time Dental Surgeon shall be of good health.
9. The Part-Time Dental Surgeon shall be governed in respect of matters not referred to in these terms and conditions by any orders/amendments to the terms contract issued by the Railway from time to time.
10. The Part-Time Dental Surgeon shall not exercise any financial powers.
11. The Part-Time Dental Surgeon shall not initiate/review/accept the annual confidential reports of Group 'C' Railway employees.
12. The Part-Time Dental Surgeon shall not indent or condemn/recommend for condemnation of any tools & plants.
13. He/She will attend the hospital for four hours daily every day on all working days. But he/she may whenever required by the Head of the RWF Railway hospital, shall attend hospital at any time during the day or night in cases of emergencies. During the prescribed hours of duty, he/she shall not attend to any private patient or shall not leave the premises of the unit in which he/she is engaged except with the permission of the Head of hospital/Unit.
14. He/she will be required to perform minimal restorative dentistry, periodontal treatment, extraction, endodontic treatment and any emergent treatment.

15. He/she will not be entitled to any concession granted to Railway employees and their families. In case of exceptional emergency cases, if any, referred to his or her private clinic or he/she being called to attend the cases at the railway dental clinic, he/she does so free of charges. No extra payment will be made to him/her for the service thus rendered.
16. In case, he/she is unable to attend the hospital, he/she will have to give prior notice so that alternative arrangements can be made.
17. He/She will not be authorized to issue any certificate either to the employees or their families or dependent relatives in his/her official or private capacity.
18. Normally Sundays and Notional holidays will be off.
19. Facility of Railway pass shall not be allowed.
20. This notification is subject to any changes/guidelines/instructions issued by the Railway Board time to time.
